

#### STRUCTURE, GOVERNANCE AND MANAGEMENT

#### **Governing structure**

St. Mark's Unitarian Church is a Scottish Charitable Incorporated Organisation (SCIO) Scottish Charity Number SC014167.

Its governing document is the Constitution adopted in 2013 and revised in 2021.

The Society is an autonomous body which is voluntarily affiliated to the General Assembly of Unitarian and Free Christian Churches and to the Scottish Unitarian Association.

#### Trustee recruitment and appointment

The members of Council (maximum 9, minimum 7, in normal circumstances) are the charity trustees.

The trustees are elected from amongst the members, by the members at the Annual General Meeting. If a vacancy arises, an additional member of Council may be co-opted.

Officers are appointed by the Council subsequent to the Annual General Meeting.

Final authority in the Society is vested in the members acting in a general meeting at which only members may vote.

#### **OBJECTIVES AND ACTIVITIES**

St. Mark's Unitarian Church has the following aims:

- · To encourage spiritual and personal growth.
- To encourage the development and spread of Unitarian principles.
- To promote Unitarian ideals and Unitarianism by working with other Unitarian groups.
- To provide fellowship and spiritual support.
- To further grow our community, spiritually and numerically.
- To maintain, preserve and enhance the church premises and to optimise the use of our premises and material resources for the furtherance of the Society's aims.
- To liaise with the Scottish Unitarian Association and General Assembly of Unitarian & Free Christian Churches in furthering our mutual aims.

## Our main activities in relation to these aims are:

- Provision of services of worship, and other services e.g. rites of passage, services to mark special events.
- Rites of passage services are available to all, not only members of our community.
- Provision of spiritual and social activities outwith regular Sunday services.
- Encouraging involvement and representation with other groups, both Unitarian and other like-minded organisations.
- Encouraging the involvement of members in Church activities.
- Financial assistance to support lay ministry and outreach; sponsorship of delegates attending national Unitarian events.
- · Charitable donations to Unitarian and other causes.

#### **Achievements and Performance**

2022 started well for the community of St. Mark's.

At the start of the year, a wide range of interesting and thoughtful services were being delivered via Zoom, with good online attendance. In the Spring, we moved back to services mainly being held in St. Mark's, with a Zoom option. Many of the congregation were pleased to be back in our building and St. Mark's remained committed to providing a Zoom presence each week for participants unable to attend in person. New people started attending St. Mark's and visitors were coming back.

The technical team were commended on the hard work which lay behind delivering this new technological feat each week. Work was ongoing and had a focus on improving sound quality. This was of particular importance, as the congregation greatly appreciates the playing of our much-valued professional pianist.

We continued to let our building for events both as a means of raising funds and as a way of allowing a wide range of people to experience the special atmosphere and heritage of our beautiful Grade B listed building.

On Council, work continued to update our policies and procedures and we now have in place robust policies on:

- Safeguarding
- Diversity, Equality and Inclusion
- Conflict of interest, with Register of Interests
- A Code of Conduct
- Grievance and Complaints
- Bullying and Harassment

Teams such as the Ministry Team, the Management Team, the Pastoral Care Team, the Finance Team and the Communications Team all continued to work together to ensure that life in our community flourished and all are thanked for their often unseen efforts. St. Mark's continued to produce an informative weekly e-bulletin which is virtually delivered to in excess of 250 people.

In June, Council elections took place and many of the Council stood down. The retiring Council were warmly thanked for their unstinting work in guiding us through a turbulent previous year. A new Council was elected comprising of Ann Sinclair, Brian Robertson, Jill Woolman (Convenor), Joan Cook, Julie Finneran, Naomi Keir and Tom Stamper.

Unfortunately In July, St. Mark's was greatly saddened by the unexpected death of Tom Stamper. Tom was a great friend of St. Mark's and a very effective member of Council and it was a further loss when his wife, Jill Woolman (Stamper) understandably stood down as Convenor, for family reasons.

This left the Council with five members and Julie Finneran became Convenor. Five on Council is two members short of the ideal number but as Council has the power to co-opt

new members to Council, it was decided to continue with five members in the expectation that volunteers could be found. Regrettably, despite invitations, no-one came forward.

SMART goals were set, with SMART standing for:

S - Specific

M - Measurable

A – Achievable

R - Realistic / relevant

T - Timely / time specific

## The Smart goals set were:

- a) Roof: To critically review the upper hall roof situation and create a practical proposal for membership for consideration by March 2023.
- b) Identify and recruit at least 4 additional people to help with the short and long term running of Unitarians in Edinburgh by October 2023.
- c) Social Events: To plan, coordinate and run 3 social events to encourage participation and collaboration within the community by June 2023.

Regarding the Upper Hall roof, which continued to deteriorate, much work was done to ascertain what work would be required to remedy the situation, estimate costs and to explore if any grants might be available. St Mark's is grateful to Hardies for their help with this project.

As we headed towards Christmas and our Compassionate Christmas service, we reflected on those we had lost from our community over the year and thought of their loved ones. We also thought of those people who are friends of St. Mark's and no longer attend but are still very much in our minds.

As always, we are indebted to those people in our community who continue to support St. Marks through volunteering time, contributing financially or attending and participating in our services. We're also grateful to our caretaker, cleaner and website manager for their efforts.

In conclusion, 2022 as a year had highs and lows but we have many assets in term of our building and our people and we hope that St. Mark's building and St. Mark's community will, through our efforts, continue to thrive.

#### **Ministry & Worship**

Services of worship were held on Sundays, usually in church and always streamed, with one Sunday service per month always solely available via Zoom. We are grateful to visiting ministers and preachers and to all members of our community who have contributed to our services.

The following groups have met regularly during 2022:

In 2022, 1 funeral was conducted by our former minister, 1 funeral by a member of the congregation, 4 funerals and 1 wedding, were conducted by our Celebrant & Lay Preacher.

#### **Raising our Profile & Outreach**

St Mark's has a dedicated Communications Team and employs various means of communicating with its members, friends and the wider community by use of social media, its website and via the weekly e-Bulletin updates.

St Mark's continues to support the following organisations on a regular basis:

Chennai Unitarian Christian Church Edinburgh Interfaith Association

St Mark's is also able to support other charitable concerns by way of one-off donations.

St Mark's maintained the following affiliations in 2022:

#### Venue and Fabric

Lettings largely reverted to their pre-Covid pattern, happily renewing previous connections and introducing some new ones and all bringing welcome income. We presented a successful Festival Fringe programme, albeit at about half our typical capacity pre-Covid.

Fibre broadband was installed at the beginning of the year. Thereafter our streaming facility was further developed in-house, led by our caretaker. A technical team to operate the system during services was established and, with experience, the quality of transmission gradually improved.

A new pump assembly was fitted to the heating system at the beginning of the year.

After many delays, in July we received Hardies' report on their survey of the upper hall roof. Once we were able to meet with their representatives, we were advised that urgent work was needed on the flat roof above the kitchen and that the north side of the main hall roof was nearing the end of its life. By the end of the year, under persistent rain, the roof was dripping water in one area. We were aware that if the upper hall became unusable or unsafe we would have to cease lettings leading to the view that action was inevitable during 2023.

#### Financial Review for 2022

#### Our policy on reserves

The Members adopt a cautious and prudent approach to reserves. The view of the Members is that the free unrestricted reserves, excluding tangible fixed assets and investments, should provide a resource for major projects and repairs, and that they should not be used to finance routine expenditure. However, it is recognised that the Church may require some of the income generated by investments to assist funding of Church activities.

#### Comments on the accounts

The layout of the accounts follows the format advised by the Office of the Scottish Charity Regulator (OSCR). You may find the pages towards the end, which detail our receipts and payments during 2022, useful for understanding where our money comes from and how we use it.

Our primary source of income is giving by our congregation, on which we claim Gift Aid whenever possible. During 2022 the number of monthly donors decreased and overall 'live' giving was down compared with 2021. We gratefully received a number of one-off donations and Sunday collections were up compared with 2021. We benefitted from a legacy of £5000 from the estate of Richard W Paul: Dick attended St Mark's during Rev Andrew Hill's ministry and beyond. Additionally we received a special payment of over £9000 from the Speed Trust [see page 12 of this report]. Our income from lettings reverted to pre-Covid levels.

Speed Trust income has been used to pay for maintenance of our website and for licences to allow us to stream our services.

We retained Lindsays Prism services until we were confident that the review and development of our policies and procedures was complete. Lindsays will retain confidential records of the legal and advisory work over grievance procedures, which they undertook for us in 2021, for a minimum of 10 years.

The independent examination of the 2021 accounts was undertaken pro bono by a member of the congregation who is a chartered certified accountant. We are very grateful for her advice and expertise.

#### Looking to the future

Venue activity has provided a valuable supplement to our income. We provide a useful service to our hirers and have good relations with them. We do need more support with the facilitation of lettings if we are to maintain and grow this aspect of our activity in the coming years.

Congregational giving will likely be down in 2023 due to a decrease in donors and the cost-of-living increases affecting everyone. Members and supporters should be reminded that their financial giving is essential to the life and work of the church and community and if we are to recruit a new minister, they will need to be financially supported. In the meantime our income may be expected to meet our immediate needs.

A major refurbishment of our beautiful Grade 2 listed premises was completed in 2015 but our building still requires continuing upkeep, in addition to routine maintenance. By the end of the year it was clear that the upper hall roof would need attention in the near future: the extent of the work required and likely cost was being investigated by Hardies [Property and Construction consultants].

Stock markets fell over 2022 and dividends remained depressed, inflation remained high, the war in Ukraine continued with mounting unrest elsewhere. Even though we will have to realise some of our assets to pay for the upper hall roof, it is fortunate that at present we do not need to look to our investments for additional income.

#### **Notes to the Accounts**

#### St Mark's Investments

St Mark's has two portfolios which are managed by RBC Brewin Dolphin in line with investment objectives and a risk classification which have been discussed and agreed with the Trustees.

Each portfolio is self-contained, in that all dividends, all management fees and all dealing fees are accounted for within the portfolio. The value of each portfolio rises and falls with the value of its constituent holdings, the income received and the fees deducted. The profits and losses deriving from sales and purchases of holdings are also contained within the overall value of the portfolio.

The **Geddie Fund** derives from a legacy received from the estate of Miss Mary Geddie. On 1<sup>st</sup> January 2022 the fund had a value of £406,513; on 31<sup>st</sup> December 2022 its value, after all income and costs, was £358,114. Brewin Dolphin management fees for the year totalled £2,226 and dealing charges totalled £1,115; underlying costs of external funds in the portfolio totalled £1,884 so the total fees and charges for the year were £5,225. On 1<sup>st</sup> January 2021 the value of the fund was £357,813.

The Capital Reserve Fund derives from the balance left following extensive refurbishment work of our premises over 2012-2015 which was primarily funded from the sale of our manse. On 1st January 2022 the fund had a value of £52,932; on 31st December 2022 its value, after all income and costs, was £46,290. Management fees for the year totalled £294 and dealing charges totalled £262; underlying costs of external funds in the portfolio totalled £313 so the total fees and charges for the year were £869. On 1st January 2021 the value of the fund was £47,211.

Thus at 31<sup>st</sup> December 2022 the total value of our investments managed by RBC Brewin Dolphin was £404,404.

St Mark's also has a holding with **Shared Interest** which was valued at £1137.54 on 31 December 2022. Interest of £2.83 was received on 31 March 2022.

#### **Restricted Fund**

The **Speed Trust** is managed by the British & Foreign Unitarian Association which operates from Unitarian Headquarters in London. During 2022 we learned that, as allowed under the terms of Mr Speed's will and in consultation with the auditors of the Trust, the proper use of Speed income has been re-defined such that it must be used to 'support Unitarianism'.

The original Speed bequest totalled £278k in 1984 but, over time, there has been a growth in the value of the capital so it is now worth some £900k. This growth in the capital amount can be properly regarded as 'unrealised income', not as 'capital' per se. In consequence, we received a special payment of £9034 in addition to the usual quarterly distributions of income.

No payments or expenses were paid to trustees.

#### INDEPENDENT EXAMINER'S REPORT ON THE ACCOUNTS

to the trustees of St Mark's Unitarian Church, Edinburgh

#### Registered charity number SC014167

I report on the accounts of the charity for the year ended 31 December 2022 which are set out on pages 3 to 14.

#### Respective responsibilities of trustees and independent examiner

The charity's Trustees are responsible for the preparation of the financial statements in accordance with the terms of the Charities and Trustee Investment (Scotland) Act 2005 (the Act) and the Charities Accounts (Scotland) Regulations 2006 (as amended). The charity trustees consider that the audit requirement of Regulation IO(1)(d) of the Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1)(c) of the Act and to state whether particular matters have come to my attention.

#### Basis of independent examiner's statement

My examination is carried out in accordance with Regulation 11 of the 2006 Accounts Regulations. An examination includes a review of the accounting records kept by the Charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently I do not express an audit opinion on the view given by the accounts.
